## **GARAGE SALE ZONING PERMIT** AS REOUIRED BY SECTION 420 OF THE DINGMAN TOWNSHIP ZONING ORDINANCE

#### **INSTRUCTIONS:**

- 4. Return to the Zoning Officer at least 10 days prior to garage sale.

#### **SECTION A:** Regulation Summary

- 1. A Dingman township Zoning Permit is required by any property owner or tenant desiring to hold a garage sale, yard sale, attic sale, tag sale, rummage sale, or any other sale of tangible personal property on a residential, unimproved, or commercial property not having a valid zoning permit to conduct retail sales.
- 2. Application for a zoning permit must be made at least ten (10) days in advance of the proposed sale.
- 3. Sales may be conducted only between the hours of 9:00am and 5:00pm.
- 4. No more than four (4) sales may be conducted in any calendar year.5. No sale may be conducted for more than two (2) consecutive days.
- 6. In the event that the sale is cancelled due to inclement weather, sales conducted on weekdays may be rescheduled for a date immediately after the weather improves. If the cancelled sale was to be conducted on a weekend, the sale may be rescheduled for the following weekend.
- 7. The sale permit must be prominently displayed at the sale site.
- 8. No sign may be placed on the sale site prior to one week before the sale.
- 9. All signs, both on, or off site, must have a valid Dingman Township Zoning permit as required by Article five of the Zoning Ordinance.
- 10. All signs must be removed within twenty-four (24) hours after the sale is completed.
- 11. Failure to abide by the regulations may result in a penalty not to exceed \$500.00 per violation

#### THE ABOVE LISTED IS A SUMMARY OF THE REGULATIONS PERTAINING TO GARAGE SALES. THE APPLICANT IS ADVISED TO FAMILIARIZE HIMSELF/HERSELF WITH THE DINGMAN TOWNSHIP ZONING ORDINANCE PRIOR TO APPLYING FOR ANY ZONING PERMIT.
