ITEM NO. 1: CALL TO ORDER

Chairman Mincer called the meeting to order at 7:00 pm opening with the Pledge of Allegiance.

ITEM NO. 2: APPROVAL OF MINUTES

ITEM NO. 3: COVID19 RELATED BUSINESS

- A) All construction activity was allowed to resume as of May Ist.

ITEM NO. 4(B) Cleanup Day & Electronics Recycling Cleanup Day has been rescheduled for Saturday, August 15, 2020 from 8 am to 2 pm. The Electronics Recycling event has been rescheduled for Saturday, September 12, 2020 from 8:30 am to 1 pm at the Township Park.

ITEM NO. 5: NEW BUSINESS A) Paving/Oil & Chip Estimates Jim Snyder obtained estimates for Fisher Lane, Cliff Park Road, and Bridge Road. The estimate to pave all three is \$153,143; the estimate for Oil & Chip is \$110,818. The Board authorized advertising for bids to pave the three roads. Supervisor Brink requested Jim crack seal the major cracks on Fisher before it is paved. It was further agreed that since the asphalt pricing is so low, to get estimates on other roads to consider for paving this year.

He would like to build and operate one of these homes on his 95 acre property. He understands that the use is not allowed in the current zone, but is requesting the ordinance be amended to allow it as a Conditional Use, The Board decided to discuss his request in Executive Session.
